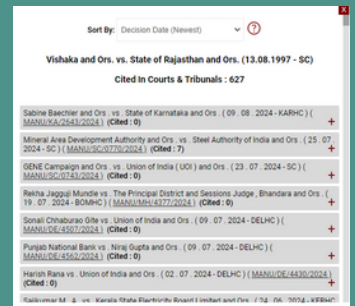
Finding the Judgments That Matter

Displays key paragraphs of a judgment based on the frequency with which they have been cited in other judgments.



Enhancing Case Comprehension with Visualization

Enables quicker comprehension of the case's significance and context, making it easier to identify key precedents and trends without sifting through dense legal text.



Case map

Offers a visual representation of the top 20 cases related to a subject case. These top cases include those cited by the subject case and cases where the subject case has been cited. This graphical depiction of case relationships also aids in identifying other potentially relevant cases.

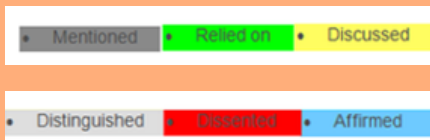


Find the relevant Precedent

Flag Indicators

Blue Flags

Blue Flags mark Acts that have received the President of India's assent but are not yet enforced.

Yellow Flags

Yellow Flags indicate that a judgment has been partially overruled, with a link to the overruling judgment for further reference.

Red Flags

Red Flags denote judgments that have been fully overruled, providing access to the judgment that overturned it.
